### Bandana Shrestha, State Director



**Bandana Shrestha** has been State Director for AARP in Oregon since July 2021 representing the interests of over 500,000 members and overseeing the work of six professional staff and over 150 volunteers to advance AARP's social impact agenda for all persons 50 and older statewide. Prior to her current role, Bandana served as Director of Community Engagement and led AARP's livability work in the state, including growing and supporting the Network of Age-Friendly Communities, advocating for policies and programs that enhance affordable and accessible housing options, and expanding transportation and mobility options for all. Before joining AARP in 2005, Bandana served as Director of Model Programs and Partnerships for the Points of Light Foundation where she developed and led volunteer programs for community innovation and leadership development across general and multicultural audiences. She holds a BA from Linfield College, an MFA from the University of Oregon, and a certificate in Gerontology from the University of Southern California.

**J. Michael Schultz's** 35+ year nonprofit career focused on philanthropy, administration, and executive leadership. Formerly, he served as Vice President of Community Impact and Director of Strategic Marketing for the United Way of the Columbia Willamette where he helped develop funding strategies for community investments and impact initiatives such as 211info, Success by Six, and other community enhancement programs. In his early career as Executive Director for the Southeast Asian Refugee Center in Vancouver, WA and Head Start Director for Utah Navajo Development Council, he served immigrants, refugees, and marginalized communities. He has held many professional leadership roles, including Chair of the 211info Board of Directors, Co-chair of Oregon Volunteer Commission, Chair of Multnomah County Citizen Involvement Committee, and President of the American Marketing Association's Oregon Chapter. ### Jay Bloom, Executive Council Emeritus



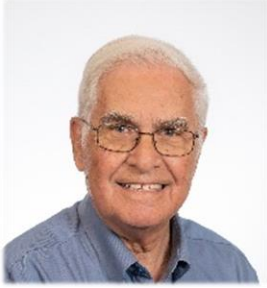

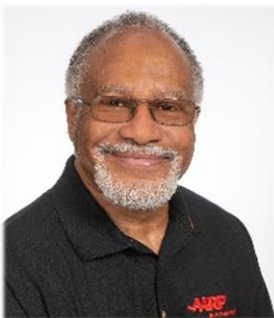
Business College in Atlanta.

**Margaret B. Neal, Ph.D.**, is Professor Emerita of Urban Studies at Portland State University. She directed the University's Institute on Aging from 2003 to 2018 and taught graduate courses in gerontology, survey design and data collection, and global aging. In 2006, Dr. Neal led Portland's participation in the World Health Organization's Global Age-Friendly Cities project. Since then she has co-coordinated the Age-Friendly Portland and Multnomah County initiatives. Dr. Neal's research interests include age-friendly and dementia-friendly communities, transportation and neighborhood design for healthy aging, older workers, global aging, program evaluation, and work and family care issues. Dr. Neal is a Fellow of the Gerontological Society of America and the Academy for Gerontology and Geriatrics in Higher Education, and she is the current president of the Oregon Gerontological Association. Dr. Neal holds master's and doctoral degrees in urban studies specializing in gerontology and research methods from Portland State University and her Bachelor of Arts degree in Spanish from Indiana University.

### **Jeanne Teisher, Executive Council**



**Jeanne Teisher** currently serves as State Coordinator for the AARP Foundation Tax-Aide Program. Her first career path was teaching physical education and coaching junior high girls in Texas and then working with people with intellectual disabilities in New Mexico. That position led her to New Mexico Special Olympics (NMSO) where she held positions as the Program/Training Coordinator and the Executive Director. In 1990, she moved to Beaverton with her husband Jim. For ten years, she continued in the human service, non-profit field developing and managing programs for high-risk youth in the Washington County area. After 26 years of working for non-profits, she changed careers, and began with Nike in 2000.
