**PRME Statement on Ukraine** (posted on 26 February 2022, updated 7 March 2022)

The community of PRME expresses its deep solidarity with all Ukrainian citizens and everyone who lives in Ukraine amid the current situation.

Among the crucial values we promote and implement in the PRME community are respect, responsibility, and cooperation. The present military offense is against the values we follow and represent. We are against violence of any kind. We call for a ceasefire and encourage the search for solutions in a socially responsible, civilized way with respect for human rights.

We express our solidarity and support for our Ukrainian friends. We strongly condemn the attack on their sovereignty and livelihoods by the Russian government, in accordance with the most recent Resolution passed by the UN General Assembly on 2 March 2022.

# Timeline of PRME response

- On 26 February 2022, PRME made its global statement on the Russian invasion of Ukraine. The statement was drafted by the PRME community members with the closest proximity to the situation, namely members of the PRME Chapter Central and Eastern Europe and PRME Chapter Eurasia.
  - On 1 March 2022, we reached out to PRME Signatory Members in Ukraine to offer our support and condolences. We confirmed on 8 March 2022 with the PRME Board's Risk and Finance Committee that we are alleviating all financial and reporting requirements for Ukrainian Signatories this year, 2022.
  - On 9 March 2022, the PRME Secretariat and PRME Chapter Central and Eastern Europe met to discuss how to approach work with Russian institutions amid the circumstances and how we can best give visibility and support to our Ukrainian colleagues.
  - On 11 March 2022, key members of the PRME community who have been spearheading these important conversations met to discuss the different approaches taken by the community and to set in motion this document, a PRME Call-to-Action.
  - From 21 25 March 2022, PRME Global Students will meet with the Secretariat to begin exploring ways to support Ukrainian and Russian students through the network.
  - Ongoing, connecting colleagues in Europe who are offering resources and shelter to Ukrainian peers, and encouraging other citizen-level support.

## Purpose of the Call-to-Action



In more detail, the purpose of this Call-to-Action is to;

- 1. Call for PRME Signatory Members to volunteer free online courses to Ukrainian students
- 2. Encourage PRME Signatory Members to offer scholarships and subsistence to (a) Ukrainian students wishing to continue or pursue a course of study, and to (b) Ukrainian faculty and researchers wishing to continue their work while displaced
- 3. Encourage donations to UN agencies and other organizations executing relief efforts
- 4. Invite PRME Signatory Members to report to PRME on useful examples of institutional or individual responses to this crisis
- 5. Encourage continued individual collaboration and dialogue with colleagues in Russia with the intention of promoting and advancing PRME and UN values
