- Nominations will be accepted through **December 2, 2019.**
- All nominations must be submitted to Emily Schichtel at [eschichtel@hwmuw.org](mailto:eschichtel@hwmuw.org). Please include **“Steering Council Nomination”** in the subject line of your email.
- Individuals are welcome (and encouraged) to nominate themselves for a seat.
- If you are nominating another person you will need to get prior approval from them before submitting their nomination.
- Persons whose term is ending are eligible for nomination. Term limits do not apply.
- Please share this with participants who receive services through our homelessness system to ensure they are included in this opportunity.
- The role and responsibilities of the Steering Council members can be found in the Governance Charter.
- All persons elected must be official members of the CoC upon taking office.
- It is the Nomination Committee’s responsibility to seek recommendations from the membership for qualified candidates for the Steering Committee, review the interest of currently serving and newly interested members, deliberate and present a list of candidates to the Continuum of Care members for election. There will be an open nomination period at the CoC meeting when we present the candidates for election in order to ensure we have well rounded coverage from as many categories as possible.
- Nominations will be accepted from the floor at the meeting for interested candidates who missed the opportunity to submit their nomination form by the deadline. Voting members will be instructed to write the names in on their ballots in the extra space provided.
