SUBJECT

Expedited Bill 34-22 to amend Chapter 49 Section 31(a)(2) to correct the list of Town Center areas

EXPECTED ATTENDEES

None.

SUMMARY OF KEY DISCUSSION POINTS

The Council approved Bill 24-22 Complete Streets on October 25, 2022 and it was signed into law by the County Executive on November 7, 2022. The bill established design parameters for various types of streets and roads within five area types: downtown, town center, suburban, industrial, and rural. Section 31(a)(2) of the bill lists the town centers.

Subsequently, the joint staffs have recognized that a few proposed town centers that had been recommended were inadvertently left off this list, namely: White Oak Science Gateway urban area excluding the Life Sciences/FDA Village Center (which is classified in the bill as a "downtown"), the Life Science Center South urban area in the Great Seneca Science Corridor Master Plan, the Veirs Mill/Randolph urban area in the Veirs Mill Corridor Master Plan, and the Washingtonian Town Center in the Great Seneca Science Science Corridor Master Plan. This bill would include these areas on the town center list; otherwise, streets in these areas would be designed as if they were in any other suburban area.

This bill also more precisely defines some of the other town centers. For example, in Bill 24-22 one of the town centers is "Lyttonsville Purple Line Station." The bill would amend this to read "Lyttonsville Purple Line Station urban area," which corresponds to the area near the station, not just the station itself.

This bill is proposed as an Expedited Bill so that it would be effective on February 7, 2023, right after Bill 24-22 will be effective.
