


Most voters prefer being cared for at home if they need help and believe it is extremely important to choose where services are provided.


Over eight in ten voters say that if they or a family member needed help, they would prefer to receive that help at home with caregiver assistance. Less than one in ten would prefer to receive help in a nursing home. And, nine in ten say it is extremely or very important to be able to choose where long-term care services are provided.

There is overwhelming support by Arizona voters 50-plus to increase funding and resources for long-term care for seniors.


Over eight in ten voters support increasing funding and resources for long-term care. Hispanic/Latino adults 50+ in Arizona also support increasing funding (92%) as well as those adults 50+ in Arizona who are currently or have been a family caregiver (86%).

There is overwhelming support by Arizona voters 50-plus to require nursing homes to put the majority of taxpayer funding toward staffing and safety.


Exactly nine in ten voters support a requirement that nursing homes and other long-term care facilities put the majority of taxpayer funding received from the state or federal government toward adequate staffing and safety protocols. Hispanic/Latino adults 50+ in Arizona also support this (94%) as well as those adults 50+ in Arizona who are currently or have been a family caregiver (91%).



Q23. Do you support or oppose requiring nursing homes and other long-term care facilities to put the majority of taxpayer funding they receive from the state or federal government toward adequate staffing and safety protocols to ensure quality care for residents? Q24. Is that strongly or somewhat? Base: All Respondents

There is overwhelming support by Arizona voters 50-plus for increasing safety inspections of nursing homes.

Nine in ten voters support increasing safety inspections in nursing homes and other long-term care facilities in Arizona. Hispanic/Latino adults 50+ in Arizona also support increasing inspections (94%) as well as those adults 50+ in Arizona who are currently or have been a family caregiver (94%).




Q17. Currently, safety inspections of nursing homes and other long-term care facilities do not occur on a regular, ongoing basis, such as monthly. Do you support or oppose increasing safety inspections of nursing homes and other long-term care facilities? Q18. Is that strongly or somewhat? Base: All Respondents

There is overwhelming support by Arizona voters 50-plus for daily, public reporting of COVID-19 cases and deaths in nursing homes.

Nearly eight in ten voters support such reporting for nursing homes and other long-term care facilities in Arizona. Hispanic/Latino adults 50+ in Arizona also support such reporting (85%) as well as those adults 50+ in Arizona who are currently or have been a family caregiver (77%).

Support by Political Party




Q15. More than 37 percent of COVID-19 deaths in Arizona occurred in nursing homes and other long-term care facilities. Arizona does not require daily, public reporting of COVID-19 cases and deaths in nursing homes and other long-term care facilities, leaving families of residents and future residents without the information they need to keep their loved ones safe, and hold these companies accountable. Do you support or oppose daily, public reporting of COVID-19 cases and deaths in nursing homes and other long-term care facilities? Q16. Is that strongly or somewhat?

There is overwhelming support by Arizona voters 50-plus to create a task force to evaluate and make recommendations about quality care in nursing homes.

Three in four voters support the creation of a task force to evaluate and make recommendations about the quality of care in nursing homes and other long-term care facilities. Hispanic/Latino adults 50+ in Arizona also support the creation of a task force (87%) as well as those adults 50+ in Arizona who are currently or have been a family caregiver (75%).


Methodology

- Objectives: To explore the opinions of Arizona adults age 50 and older on long-term care proposals being considered by the Arizona State Legislature.
- Methodology: Telephone survey (both landline and cell).
- Qualifications: Age 50 or older and registered to vote in the State of Arizona.
- Sample: Registered voter list targeting ages 50 and older from Aristotle International (N=1,001).
- Interviewing dates: April 22, 2021 to May 8, 2021.
- Weighting: The data is weighted by age, gender, ethnicity, and AARP membership status.
- Questionnaire length: Interviews averaged 16 minutes in length. Full questionnaire is available upon request.
- Confidence interval: Total sample: ± 3.1%.
