Introduction

Dear Municipal Official,

The Supplier Diversity Office (SDO) is a Commonwealth oversight agency tasked with promoting equity and inclusion in state procurement and contracting. The SDO certifies a wide range of diverse and small business categories, issues policies, and coordinates diverse and small business programs for the Commonwealth's executive agencies. The SDO also puts diverse companies in touch with government agencies and their prime contractors regarding business opportunities.

This publication is a refresh of the Municipal Supplier Diversity Playbook (the Playbook), which the SDO issued in 2021 after receiving numerous inquiries from municipal governments interested in establishing supplier diversity programs focused on their local communities. The Playbook creates a framework for establishing and developing a local supplier diversity program. This updated Playbook includes information about new SDO resources available to assist municipalities and your vendors, including the Supplier Diversity Hub and the Certified Diverse Business Dashboard/Map.

The Playbook exists in the form of PowerPoint, which is used by the SDO for live presentations at municipal meetings and training sessions. Organizations interested in implementing diverse and small business programs must consider their unique needs and may use these slides as checklists for potential initiatives, lists of best practices, and resources available from the SDO. In addition, each municipality should consult their own legal counsel and the Massachusetts Office of the Inspector General to ensure their program follows applicable laws and is legally defensible.

Small Business Purchasing Program (SBPP)

Goal: Increase spending with small businesses

Purchasing: Use small businesses to the extent possible based on contract terms, departmental policies, laws, and regulations

RFQs and Open-Market Procurements (≤\$250K/year): Award to a Massachusetts-based small business that meets the department's best value criteria.





Application through COMMBUYS, with Department of Revenue verification:

- Principal place of business in Massachusetts;
- Business operating for at least one year;
- Currently employs no more than a combined total of 50 full-time equivalents in all locations;
- Gross annual revenues of \$15 million or less based on a 3-year average

The program applies to Massachusetts executive agencies as well as entities that participate in it voluntarily. More at <u>www.mass.gov/sbpp</u>.

Supplier Diversity Program (SDP)

Goal: Increase participation of diverse businesses

Purchasing: Use diverse businesses to the extent possible based on contract terms, departmental policies, laws and regulations

Open-Market Procurements (>\$250K/year): Require prime bidders and contractors to maintain partnerships with diverse businesses.

SDP Evaluation: Evaluation of SDP form must be at least 25% of total evaluation criteria.

Municipal Construction Affirmative Marketing Program (MCAMP)

For established programs, a typical cycle is one year, but new programs may choose the duration of each program iteration.





Step 1: Plan Program Setup



Plan: Your Program Setup



Action	Description
Decide on program track	Choose a program track: Purchasing Contracts and procurement Fostering partnerships
Ensure support from the top	High-level support is vital for establishing the legitimacy of your efforts.
Convene a team	Your team should include representatives of procurement, IT, economic development, and other departments.
Establish your baseline	Analyze your current spending to identify certified diverse vendors.
Create a plan	Develop a plan, whether goal-based or focused on piloting and monitoring supplier diversity measures. Commit to completing the four steps of this methodology during the plan cycle before you expand the scope of your program.



Plan: Your Program Setup



Action	Description
Determine your metrics	Based on your baseline, determine what metrics you are going to focus on and work with your IT, accounting, and/or procurement department to agree on access to this information.
Prepare documentation	 Examples: List of diverse vendors available to buy from Updated procurement procedures Contract language and forms These changes may be limited in scope in the beginning and expand as you develop supplier diversity expertise.
Communicate	Communicate your efforts to your stakeholders: staff, vendors, and community advocates.

Program Implementation: Purchasing



Action	Description
1) Identify certified diverse contractors	Assess your current contractor base and identify current certified contractors.
2) Survey contractors for certification potential	Survey current contractors to find any contractors that are not certified but are eligible for certification. Communicate the information to the SDO and encourage suppliers to apply for certification.
3) Inform buyers of diverse purchasing options	 Inform the buyers about their options for buying from diverse businesses. Be clear about: Know your diverse vendors – ideally, diverse vendors should be tagged on lists and in systems buyers already use What products and services are available – ensure that buyers only purchase approved products/services How to buy - any quotation, price comparison, approval, and/or other procedures required prior to ordering
4) Buy from diverse suppliers	Order from diverse suppliers. If quotation or price comparison is required, instruct buyers to include eligible diverse suppliers in your request for quotes or comparison.
5) Track spending	Track your organization's spending with diverse suppliers

Program Implementation: New Procurements



Action	Description
1) Choose a business opportunity	Choose an upcoming business opportunity or purchasing need.
2) Identify eligible bidders	Identify eligible diverse suppliers that may be capable of providing the product/service. The SDO can help you with this!
3) Market the opportunity	Market the opportunity to eligible diverse suppliers.
4) Conduct the procurement	Conduct a competitive procurement in accordance with applicable laws and regulations.
5) Inform buyers of new diverse vendors	Inform purchasing staff of newly available diverse suppliers, products, and services available on contract, and the process for ordering from them
6) Track diverse spending	Track your organization's spending with diverse suppliers and/or compare the number of diverse suppliers to the previous contract.



Pilot your approach. Launch your effort with one new procurement. This will allow you to test the contract language, forms, and evaluation process.

Imagine Yourself as a First-Time Bidder

What does the bid solicitation look like? Consider reducing the ...

- Number of separate documents
- Number of separate forms to complete
- Total number of pages to read

What is the bidder required to send back? Consider providing...

• A clear list of all required documents in one place

Is it clear how to get help? Consider offering...

- A recorded pre-bid conference that includes a presentation on the scope, requirements, and response expectations
- Training on how to submit a response

Are the requirements realistic for a small business? Consider...

- Unbundling the scope or splitting it into categories
- Reworking essential requirements (e.g. number of years in business vs. principals' experience, government client experience vs. institutional client experience, etc.)
- Removing requirements used to reduce the number of bids rather than ensure quality

Will the vendor hear back from you? Consider...

• Ensuring that each bidder hears from you regarding the results of the solicitation



Program Implementation: Fostering Partnerships



Action	Description
1) Choose a business opportunity	 Choose an upcoming procurement where future contractors will be required to spend money with diverse businesses through: Subcontracting, and/or Ancillary products and services (general business needs)
2) Include contract language and forms	Include supplier diversity contract language and forms to require bidders to propose a supplier diversity commitment. Train potential bidders on partnership options and what information is required.
3) Conduct the procurement	Conduct a competitive procurement in accordance with applicable laws and regulations. Treat the supplier diversity commitment as a requirement and/or assign additional evaluation points for the proposed partnership (as appropriate and based on what is allowed by law).



Pilot your approach. Launch your effort with one new procurement. This will allow you to test the contract language, forms, and evaluation process.

Action	Description
4) Facilitate new partnerships and support compliance	 Following award: Hold a networking event to facilitate additional subcontracting and ancillary partnerships Provide prime contractors with training and resources to identify potential subcontractors and ancillary diverse partners
5) Inform buyers	Inform purchasing staff of the relative levels of supplier diversity spending commitment for each awarded contractor. Make a preference for contractors with higher commitments.
	Set your contractors up for success from the outset.
6) Track spending	Regularly distribute reporting forms and collect spending reports from contractors. Ensure reporting and supplier diversity spending compliance.



I am pleased to present the Supplier Diversity Office's (SDD) Comprehensive Annual Report for Fiscal Year 2022 (FY2022), which also includes narrative descriptions of supplier diversity programs and/or results from 14 Commonwealth of Massachusetts quasi-public/non-executive organizations.

The SDO became a separate state agency under the Executive Office for Administration and Finance in 2021, a change which elevated the SDO to an oversight agency and codified SDO programs and certification categories. This change and the issuance of Executive Order 599 on June 24, 2022 strengthened the SDO's ability to carry out its important mission of promoting diversity in state contracting and increased opportunities for underrepresented businesses.

Consistent with the directives in MGL c. 7, §§ 61 and Executive Order 599, the SDO provides certification, programs, training services, and access to business opportunities and resources for Minority (MBE); Women (WBE); Veteran (VBE); Service-Disabled Veteran (SDVD8E); Disability (DOBE); and Lesbian, Gay, Bisexual, and Transgender (LGBTBE) owned businesses, as well as small Massachusetts businesses. The accompanying report includes information about the Commonwealth's diverse and small business programs, including the Certification, Supplier Diversity (SDP), Small Business Purchasing (SBPP), Affirmative Marketing, and Individuals with Disabilities programs.

I am pleased to provide the following highlights from the attached SDO FY2022 Annual Report:

- Growth in total diverse spending. The Commonwealth spent approximately \$3.26 billion with diverse and small businesses (a 15% increase over FY2021), which includes discretionary (or program) spending of approximately \$2.12 billion (a 13.5% increase over FY2021) and nondiscretionary (or nonprogram) spending of approximately \$1.15 billion (a 16.8% increase over FY2021).
- Growth in spending by category. In FY2022, discretionary spending grew in the MBE, WBE, SBPP, DOBE and LGBTBE categories by 26.4%, 11.6%, 13.5%, 24% and 76.6% respectively compared to the prior year. Spending with veteran-owned businesses declined by approximately 40% in large part due to changes in spending on two large Commonwealth construction projects.
- Benchmark performance. Program participants exceeded spending benchmarks for MBE, WBE, and SBPP by 13.5%, 41.2%, and 34.6%, respectively. The Commonwealth continued its efforts to meet its ambitious veteran-owned business benchmark. Although three Executive Branch secretariats and one constitutional office exceeded their veteran goals, additional vendor capacity is needed to meet the benchmark and make veteran spending stable year over year.
