









EXPLANATORY NOTES

Although Brazil does not have professional midwives, 2 post-nursing education programmes are available to those with a bachelor's degree in nursing, both leading to a Diploma in Specialist Obstetric Nursing, with competencies aligned with the ICM definition of a professional midwife. The residency option lasts for 24 months, during which nurses learn the obstetric specialization while employed at a health facility and paid by the government. This option is available only in the public sector and is offered by 35 teaching hospitals. The other option is a traditional 18-month education programme, offered at some public sector schools and some private sector schools.

In addition to the education programmes, the midwives' association can certify nurses based on their practical experience. They must have supported a minimum number of births, pass a theory test and provide other evidence of their relevant experience in midwifery. This process takes place every 2 years, and about 10-12 certificates are awarded each time.
